NO PURCHASE OR PAYMENT OR VACCINATION NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OR VACCINATION WILL NOT IMPROVE YOUR CHANCE OF WINNING.

ELIGIBILITY. The Urban League of Metropolitan St. Louis’ Thanksgiving 2021 TWO VAX Sweepstakes (the “Sweepstakes”) is open to citizens of the States of Illinois and Missouri, who reside within 85 miles of Downtown St. Louis and are at least 18 years of age at the time of entry. The Sweepstakes is void where prohibited by law. Employees of Sponsor, any prize providers, any participating or supporting entity including BJC HealthCare, SSM Health, Mercy Health, St. Luke’s Hospital (through the St. Louis Metropolitan Pandemic Task Force), and each of their parents, subsidiaries, affiliates, advertising and promotion agencies, wholesale distributors, and individual retail licensees, as well as the immediate family and household members of each of the aforementioned, are ineligible to participate in the Sweepstakes. Individuals under the age of 18 are not eligible to enter the Sweepstakes.

SPONSOR: The Urban League of Metropolitan St. Louis, 1408 North Kingshighway Blvd., St. Louis, MO 63113.

AGREEMENT TO OFFICIAL RULES: By participating in the Sweepstakes, entrants fully and unconditionally agree to and accept these Official Rules (the “Official Rules”) and the decisions of the Sponsor, which are final and binding in all matters related to the Sweepstakes.

SWEEPSTAKES ENTRY AND TIMING: For eligible individuals, the Sweepstakes begins at 12:01 AM Central Time (“CT”), on September 15, 2021 and ends at 11:59 PM ET, November 22, 2021 (“**Sweepstakes Period**”). Sponsor’s clock shall serve as the official clock for the Sweepstakes and participant’s proof of submission does not constitute proof of receipt by Sponsor.

The drawings will take place on November 23, 2021.

HOW TO ENTER: There are two ways to enter. 1) at a participating vaccination site; 2) by mail-in entry.

Vaccination Site Entry: Qualified individuals must perform each of the following steps in order to be deemed to have entered the Sweepstakes:

1. During the Sweepstakes Period, visit a participating vaccination site.
2. Obtain a Urban League provided entry card.
3. Complete and submit the provided form to the authorized person at the vaccination site, which asks basic information, including for example, address, e-mail and mobile phone number, first and last name, and zip code.

Check a box acknowledging that you are at least 18 years of age and another box confirming that you have read and accept the Official Rules. The rules are available at the following website www.ULSTL.com

4. If appropriate, check the box signifying that you have received your first dose or second dose of the COVID-19 vaccine at a BJC, Mercy or Urban League vaccination event, or other participating community event listed on vaccinatestl.org.

It is your sole responsibility to notify the Sponsor of a change in your e-mail address.

Mail-in Entry Without Receiving COVID-19 Vaccine: Qualified individuals must perform each of the following steps in order to be deemed to have entered the Sweepstakes without receiving a COVID-19 vaccine:

1. During the Sweepstakes Period, on a 3"x5" card handprint your name, mailing address (with zip code), email address, and daytime phone number.
2. Mail the 3x5 card in a business size (#10) envelope to: James Clark, VP of Public Safety, The Urban League of Metropolitan St. Louis, 1408 North Kingshighway Blvd., St. Louis, MO 63113.
3. Entries must be postmarked by November 18, 2021 and received by November 22, 2021 to be eligible for the drawing. Mail-in entries will be entered into the drawing based on the date postmarked.
4. No copies, stamped or mechanical reproductions of mail-in entries will be accepted. Mail-in entries become Sponsor's property and will not be returned. Sponsor and Administrator are not responsible for postage due mail.

Limit of one (1) entry per person for the entire Promotion Period, regardless of method of entry. Multiple entries and/or mass entry attempts will result in disqualification of all entries by such person and may constitute an act of fraud. Use of automated entry devices or programs, or entries by third parties are prohibited. Entries that do not conform to or that violate these Official Rules or are submitted in any manner other than stated in these Official Rules will be disqualified. Proof of submission of entry does not constitute proof of receipt of same. Entries will not be returned. Receipt of mail-in entries will not be acknowledged. By entering this Sweepstakes, entrants agree to these Official Rules and the decisions of the Sponsor, which are binding and final in all matters relating to this Sweepstakes. PRIZE/VALUE/ODDS: Two (2) prizes will be awarded during the Sweepstakes. One 2022 Chevy Equinox – MSRP - \$25,800, and One Ford Escape 2021– MSRP \$25,800.

Odds of winning will depend on the total number of eligible Entries received.

WINNER SELECTION AND NOTIFICATION: Potential winners will be notified by e-mail (if potential Winner enters via mail and does not include an e-mail address on 3" x 5" card, they will be notified instead via phone in Sponsor's sole discretion) on or about the Drawing date and may be required to complete, sign and return within ten (10) business days of date on notification, an Affidavit of Eligibility, Liability Release and Indemnification, a W-9 Tax form, a Publicity Release, as well as other documents that Sponsor may require (collectively the "**Prize Claim Documents**").
